UAE Family Visa

A resident of the UAE who is a foreign national can obtain a residence visa for their family. New conditions have been introduced for family residence visas in the UAE. The financial requirement for a family residence visa has been removed. Now, a minimum monthly income of 4,000 dirham's is required, which is equivalent to 302,440 Pakistani rupees. Alternatively, a monthly income of 3,000 dirham's along with proof of accommodation will be acceptable.

For family residence visas, it is mandatory for individuals over 18 years of age to undergo a medical check-up at designated medical institutions. If the family of the residence visa holder is residing in the UAE on a visit visa, they are permitted to convert it into a residence visa. This process must be completed within 60 days of entering the UAE.

Applications for the residence visa can be submitted through the authority's website. The application can also be submitted via the website or a phone application.

Which Card is better? Dubai Metro

Getting around Dubai is easier with the city's advanced rail system but when it comes to the card buying; we get confused which is better.

There are four types of "NOL" cards:

☐ **Gold-** This card gives commuters access to all the compartments of the Dubai Metro, plus commuters can access the Dubai metro's gold class seats for a premium fare as well as the gold class cabins on the Dubai Tram.

☐ **Silver-** This card gives commuters access to all the compartments of the Dubai Metro. However, male card-holders will not be able to sit at the Women and Children's compartment in the metro as well as on other public modes of transport.

☐ **Blue-** Students, senior citizens, or a person of determination have special fares for different concession types

☐ **Red-** This paper-based smart ticket can be used for Metro, Tram and Buses and loaded up to 10 trips only and has the lowest ticket price value.

I use the Gold card, when it's rush hour and Red in normal time, as I mostly using my car.

Visit Dubai 1st time

Yes, all visitors to Dubai can get a free SIM card at the airport. The SIM card is provided by du, one of the two major telecom operators in Dubai. The SIM card comes with 1GB of free data valid for 24 hours.

To get the free SIM card, simply approach the du counter at the airport immigration counter and ask for a Tourist SIM. You will need to show your passport to get the SIM card.

Once you have the SIM card, you can activate it by inserting it into your phone and dialling *122#. You will then be prompted to enter a PIN code. The PIN code is 1234.

Q: How to attest your Pakistani Educational Documents?

Today, I will tell you how to get your educational documents attested. Due to recent visa restrictions in the **UAE**, visas are now only being issued to those who have either an intermediate certificate or a degree, and the benefit of having a degree or certificate will only be realized if they are attested. Here's how to get them attested:

If you have a 12th grade or intermediate certificate or degree, first, you need to get it attested from the relevant board, whether it's **Gujranwala Board**, **Multan Board**, or any other board. After getting it attested from the board, you need to go to **Islamabad** where there is an organization called **IBCC**. You need to get it attested from there, which will take one day. After that, you need to get the certificate or degree attested from the **Foreign Office**, which is also located in **Islamabad**. Once it's attested from the **Foreign Office**, you need to go to the **UAE Embassy**. The fees for attestation at the **UAE Embassy** need to be paid online, which is **150 AED**. After paying the fee online, your documents will be attested by the **UAE Embassy**, and only then will they be acceptable.

A lot of people think that only those with a degree can get a visa, but that's not true. If you have an attested 12th-grade certificate, you can also get a visa. Moreover, there are still many professions that require a 12th-grade certificate.

Attestation of a degree:

To attest a degree, you need to submit it to **HEC Islamabad** for attestation. After it's attested by **HEC**, you need to get it attested from the **Foreign Office** and then from the **UAE Embassy** by paying a fee of **150 Dirham's online**.
